The third month of FY 2022 was very successful in community involvement. Our Police Department is making progress in many areas of concern within the community. The Department has concentrated on addressing issues raised by the citizens of Oak Island and focused on being more involved in the community.

The Department is building a stronger relationship with the community by hosting and attending multiple community events. Doing this will help us work closely together with the community to achieve a common goal. During the second month of the newly piloted program, the Department has attended or hosted a total of 20 community events.

The following is a list of community events that the Department has attended or hosted. Some of these events have been around for a long time; however, didn't have much or any Law Enforcement involvement prior to August 1st, others are events that were created and designed by the new Community Resource Officer to attempt to build a better rapport with the community.

1. 08/05/2022, Missed event. CRO. Denoble was able to get a family adopted by the Ocean View Methodist Church for a back-to-school program. This family was provided with much needed school supplies for both their children. The Church was also able to provide new clothes for both the children as well at no cost to the family
2. 10/01/2022, CRO. Denoble and Officer Phillips attended the weekly Fall music festival. They engaged members of the community in conversation, providing security and attended to any traffic control needs.
3. 10/01/2022, CRO. Denoble attended the Oak Island fall market. He spoke with attendees, vendors and handed out stickers.
4. 10/04/2022, CRO. Denoble Co-hosted a security assessment meeting with the BCSO Impact Unit at the First Baptist Church of Oak Island. A three-hour assessment was done on the house of worship for potential security issues, and a list of changes and recommendations was given to the pastor and members of the meeting. A follow up meeting will be conducted to see how much progress was made on a later date.

5. 10/05/2022, National CWAC (Coffee with a Cop) day was celebrated all around the US by hundreds of Local Law Enforcement agencies. Today the Oak Island Police Department celebrated CWAC at Scoops Donuts and Ice Cream. The event was a success and had nearly 25 total attendees. Patrons went through approximately 3 pots of coffee and brought up several topics of conversation. The Department of Insurance Criminal Investigation Division came as well and spoke about fraud and how to not become a victim of it.
